Women's Family rights

Equality in law

- Principle: women are equal with men before the law according to the constitution Family Law
- Marriage, Divorce, Maternity, Alimony
- Progress:
- Equality in blood money.
- Equal rights to guardianship and custody of minor children according to the family law.

There are texts experiencing discrimination based on gender in the family law, such as:

- Husband right to prevent his wife from completing the higher education.
- Law does not give wife the right to refuse her husband request to resigned from her job.
- Many wives have resigned from their work at the request of the husband.

- The Law does not protect the wife's from husbands abuse except the sexual right and alimony.
- Law did not elaborate specific punishment against the husband when he assaulting the wife.
- There are differences indicate discrimination against women, such as, the difference in the type of punishment for the crimes of indecent assault.
- The law Did not mention the honor crimes and fails to criminalize this kind of murder and did not specify certain penalties.
- Judges depends on customs and mores when ruling in such cases .
- Violence against women remains taboo issues


