2. Overview

Description:

Doha International Family Institute (DIFI) invites researchers and scholars inside and outside Qatar who are interested in Family Research in the Arab region to apply for OSRA Research Grant. The goal of OSRA Grant is to adapt research that focuses on Family Issues in the following areas:

1. **Family Programs and Behavioral Issues**
2. **Family Cohesion**
3. **Marriage and Divorce**
4. **Family Well-being and Protection**
5. **Parenting and Child Well-being**
6. **Family Population Dynamics**

To highlight the challenges that are facing Arab families around the world, and to contribute to developing evidence-based policies and programs to promote the well-being of families.

What is OSRA grant?


OSRA grant is an annual research grant that was first established in February 2015 as a joint grant between DIFI and the Qatar National Research Fund (QNRF), with the goal of supporting innovative and high-quality research initiatives to advance knowledge on issues facing Arab families and to provide policy-makers in the Arab world with evidence-based research and policy analysis that supports the design and implementation of new, or more effective, family related policies and programs through jointly funded grants. This grant started as a joint grant for the past five years, as QNRF was managing the local projects and DIFI was managing and acting as Research Office for the international projects. But from the sixth cycle and onwards of the grant, DIFI will manage both the national and international projects.

The grant awards each proposal team up to **50,000 USD** for a maximum period of 18 months. Grants will be made to the most innovative ideas received and selected through a competitive peer-review

5. Develop research areas within Qatar and Arab Countries.

7. Specific Research Priority Areas

The research grant support cutting-edge, basic, and applied research (including comparative and policy-oriented research) that covers a large number of topics grouped under six major themes: Family Programs and Behavioral Issues, Family Cohesion, Marriage and Divorce, Family Well-being and Protection, Parenting

and Child Well-being, Family and Population Dynamics. It is highly recommended that expected proposals are impact driven by policy and program development.

Examples of topics (but not limited) in each theme are listed below.

- 1. Family Programs and Behavioral Issues:** the focus of this theme will be on social behavior problems related to topics such as addiction (substance abuse); digital addiction, prevention programs; adolescent and/or childhood behaviors; behavior of children at schools; family behavior with children with disabilities, or any other relevant topics to the theme.
- 2. Family cohesion:** this theme will focus on topics related to intergenerational solidarity, intergenerational gaps, families, and economic sustainability, such as (climate change, environment), family resilience (in a crisis such as war or disasters), world cup and cultural diversity, women empowerment, and leadership concerning family well-being, or any other relevant topics to the theme.
- 3. Marriage and Divorce:** this theme will highlight essential topics related to internal and external factors that affect marriage and divorce. Topics of interest are youth and marriage, marital satisfaction and long-lasting marriage, delayed marriage, spinsterhood, premarital programs, programs related to ending marriage such as mandatory license prior to divorce, engagement, the impact of divorce on the family and society; post-divorce arrangement (financial and education, housing, child custody rights, single parents), or any other relevant topics to the theme.
- 4. Family Well-being and Protection:** this theme will target research on different topics related to family well-being and protection, especially in the area of childcare policies, work-family balance, family-friendly policies, cost-benefit analysis, economic abuse, financial literacy awareness program to prevent families dissolution, and the other regions of interest such as family formation policies (social welfare policies; social protection policies), or any other relevant topics to the theme.
- 5. Parenting and Child Well-being:** this theme will investigate the importance of parenting and childcare and development, specifically targeting programs and relevant policies related to the following topics: involvement of fathers in parenting, parenting styles, and practices; parenting and child well-being; delayed parenthood; transition to parenthood; the role of parents in education, parents and special needs; or any other relevant topics to the theme.
- 6. Family and Population dynamics:** this theme will explore topics related to the aging population, in particular, elderly people in Arab countries, which includes the impact of pension on elderly, empowerment of the elderly, caregivers and the elderly, social protection services for elderly, and rights of the elderly. Moreover, specific topics related to social aspects of fertility, the decline in fertility, policies and programs that promote fertility rate, or any other relevant issues to the theme.

8. Eligibility


8.1. Eligibility of Proposal

- 8.1.1. The proposal must be within one or more of the specific research priority areas indicated in **section 7**.
- 8.1.2. The proposal must include at least a Lead Principal Investigator (LPI) or a Principal Investigator (PI) from an Arab country.
- 8.1.3. The proposals must focus on subjects related to **Arab Families** in all over the world.

8.2. Eligibility of Submitting/International Institution

- 8.2.1. Applicants from all countries are allowed to apply for this grant.
- 8.2.2. To consider the ROs as "eligible," all ROs inside and outside Qatar must submit a letter from their affiliated institution when registering in DIFI-Grants Portal. For the following cycles, the ROs that are already registered on the system will not have to submit this letter. This letter can be downloaded from DIFI-Website.
- 8.2.3. Proposals should be within the research area(s) of the submitting institutions as declared by the approved ROs.
- 8.2.4. For institutions based outside Qatar, only Academic and Research Institutions are eligible to apply for this grant.
- 8.2.5. For institutions based outside Qatar, the affiliated ROs of the academic and research institutions will handle the vetting and other RO Responsibilities that are listed in DIFI-Website.
- 8.2.6. The institution of the LPIs inside Qatar will be considered the Submitting Institution while institutions of LPI outside Qatar will be called International Submitting Institutions.
- 8.2.7. Institutions other than the submitting institutions will be considered as collaborating institutions.
- 8.2.8. Authorized Research Office Representatives (ARORs) and other research administrators who are members of the RO are not eligible to participate in any OSRA projects.

8.3. Eligibility of Participants

8.3.1. Eligibility of Lead Principal Investigators (LPIs)

- 8.3.1.1. Each team must be led by an LPI who submits the research proposal on behalf of the research team.
- 8.3.1.2. An eligible LPI must hold a research-oriented doctorate or any of the approved terminal degree, as defined under the approved list of terminal degrees in DIFI-Website.
- 8.3.1.3. The LPI should have at least three peer-reviewed publications relevant to the social science field uploaded in his/her profile in DIFI-Grants Portal. The forms of publications accepted by DIFI include journal papers, full papers, conference proceedings, books, book chapters, or patents.
- 8.3.1.4. LPIs from Qatar must be employed by a Qatar-based institution, with a DIFI-approved RO.
- 8.3.1.5. LPIs from outside Qatar are eligible to apply if they are affiliated with academic or research institutions, and their ROs registration need to be approved in prior by DIFI, as explained in **section 8.2**.
- 8.3.1.6. For individuals affiliated with international submitting institutions outside Qatar and aiming at being an LPI for this call, their institutions will be called the International Submitting Institutions and their Research Offices will act as the Grant Proposal Administrator for them.
- 8.3.1.7. If affiliated to an international submitting institution from a country outside the Arab world, the LPI must collaborate with at least one PI from the Arab world.
- 8.3.1.8. A post-doctoral scholar is not eligible to act as an LPI.


8.3.2. Number of Roles

- 8.3.2.1. The LPI can submit only one application per cycle.
- 8.3.2.2. Each LPI and PI is eligible to submit and participate in only one research proposal under this call. That counts restriction excludes awarded projects under previous OSRA cycles.
- 8.3.2.3. Each LPI is eligible to participate as an LPI in up to **two** OSRA projects in all on-going cycles.
- 8.3.2.4. DIFI reserves the right to reduce the permissible number of a participant's roles based on previous award performance.

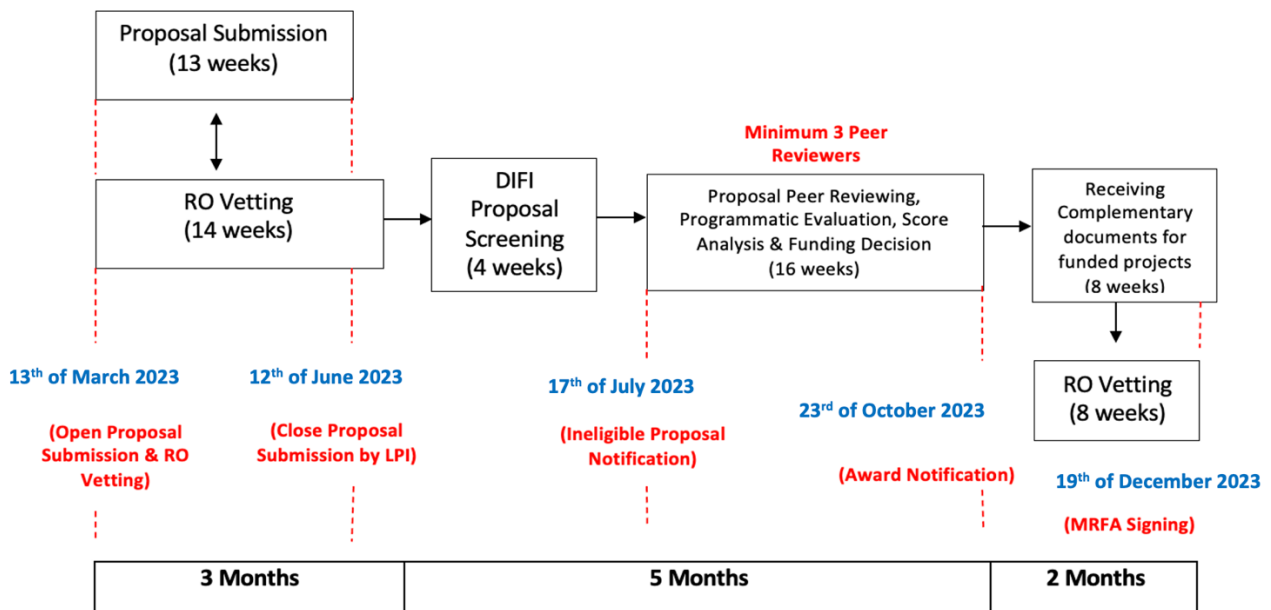
9. Submission Process

9.2. Applications Procedures

During proposal preparation, LPIs must select one of the two types of applications stated below:

9.2.1. New

- 9.2.1.1. LPI must select “**New**” application if it is the first time that the application is submitted for funding.
- 9.2.1.2. New application may also include proposals that did not pass the screening stage in previous cycles.

9.2.2. Resubmission

- 9.2.2.1. Proposals that passed screening but were not awarded in OSRA are allowed to be resubmitted in the subsequent cycle. Such proposals should be flagged as “**Resubmission.**” Resubmission is allowed once only.
- 9.2.2.2. Previous proposals that have passed screening but were not awarded and are being resubmitted as “**New**” proposals will be disqualified during the screening.

11. Personnel Requirement

11.1. Principal Investigators (PIs)

- 11.1.1. An eligible PI must hold a research-oriented doctorate or any of the approved, listed terminal degrees as defined under the approved list of terminal degrees available at DIFI-Website.
- 11.1.2. A Principal Investigator must be affiliated with a research institution from inside or outside Qatar.
- 11.1.3. A post-doctoral scholar is not eligible to act as a PI.

11.2. Graduate Students (GS)

- 11.2.1. A graduate student (GS) is eligible to participate in OSRA projects provided that he/she is enrolled in a higher education degree program at the submitting/international submitting or collaborative institution and that the OSRA research activities are related to the GS's degree program.
- 11.2.2. A GS sponsored by the Qatari government to pursue his/her studies abroad is eligible to participate in OSRA grant regardless of the institution in which he/she is enrolled.

11.3. Undergraduate Students

If necessary, the LPI may include undergraduate students as Research Team Members under the "Undergraduate Student" roles on the DIFI-Grants Portal, provided that their participation would comply with their institution's policies. Each undergraduate student shall not participate for more than 16 hours per week in the awarded project activities.

11.4. Consultant

Consultants are not permitted under this Call.

11.5. Research Assistant/Associate

A person holding university degree conducting research with the aim of:

- 11.5.1. Assisting in carrying out research tasks of a research project under the supervision of the key investigator.
- 11.5.2. Acquiring further research skills that help them along their research career.

PS: The designations "Associate" and "Assistant" are organizational and may indicate a differential in scale or duty, but the function of the general category remains essentially the same.

12. Online Submission Procedures


12.1. Submission Requirements

- 12.1.1. The online application submitted by the LPI must be vetted by the Research Office (RO) of their affiliated institutions to be considered as an official submission to OSRA Research Grant; RO vetting must be completed following the timeline (**section 9.1.2**). Please refer to the RO responsibilities at DIFI-Website.

- 12.1.2. Proposal application materials must be prepared in English or Arabic. A research plan in Arabic and English must be submitted as a PDF document. The Research Plan template should be downloaded from DIFI-Website.
- 12.1.3. All LPs and ROs listed on an OSRA grant application, residing inside or outside Qatar, must register with DIFI-Grants Portal at <https://difigrants.fluxx.io>.
- 12.1.4. Applicants are required to use their official work email addresses (if available) when registering—even the previously registered need to register again so that they can have a profile in DIFI-Grants Portal. Applicants who register with two different emails will be disqualified.
- 12.1.5. Each LPI is required to upload at least three single- or co-authored peer-reviewed publications in research areas relevant to this Call.
- 12.1.6. LPs are expected to submit the completed application through DIFI-Grants Portal at <https://difigrants.fluxx.io>.
- 12.1.7. For the requirements regarding online registration please refer to the Grant Application Guide (GAG) at DIFI-Website.

12.2. Proposal Registrations


- 12.2.1. After registration to the portal, the LPI is required to submit the proposal at the following website: <https://difigrants.fluxx.io>. For more information regarding the proposal registration and submission, please refer to (GAG) at DIFI-Website.
- 12.2.2. The LPI can use the “Comments to DIFI” box to state the names and emails of Peer Reviewers that DIFI should not utilize for evaluating the proposals, in addition to any other issue he/she must declare ahead of submission.

12.3. Proposal Preparation

During the **Proposal Preparation**, the LPI has to submit the information according to the online sections listed below and upload documents as required.

- 12.3.1. **Proposal Summary:** A brief description written in the third person outlining the significant aspect(s) of the proposed activity while illustrating the objectives and methods to be used. The description should be informative, highlighting the intellectual merit and the potential policy impact of the project; this is requested during the proposal submission phase on the system.
- 12.3.2. **Submitting Institutions:** The LPI’s institution must have appropriate research resources specialized in area(s) of the call and is responsible for submitting research proposals to DIFI. The LPI’s institution in Qatar will be considered the Submitting Institution and will be responsible for vetting the proposal. Submitting Institutions of LPs from outside Qatar will be called International Submitting Institutions, and their affiliated ROs will be their Grant Proposal Administrator and be responsible for vetting the proposals. For International Submitting Institutions, the LPI should upload an International Submitting Institution supporting letter; the template of which is available at DIFI-Website.
- 12.3.3. **Collaborative Institutions’ Information:** Research Institutions inside or outside Qatar may collaborate with the Submitting Institution/ International Submitting Institution in conducting the research proposal. In case of collaboration, the LPI should enter the required information for each collaborative institution, including uploading a collaborative institution supporting letter. Please download the letter from DIFI-Website.

- 12.3.4. **Personnel:** The LPI can nominate Research Team Members (see definition at DIFI-Website) from the Submitting/International Submitting and Collaborative Institutions. PIs are required to register to be added to the proposal submission. The portal will request the PIs to update their profiles with all required documentation/information in order to be added to the proposal.
- 12.3.5. **Research Plan:** The LPI should prepare the research plan file according to the Research Plan template available at DIFI-Website. The research plan should use Arial font for the body text, font size 11, single space, and the margins as identified in the template (no less than 0.5 inches) and use APA style. The research plan must not exceed 25 pages in total excluding cover page, table of contents and references. All submitted proposals must include an appendix report from a certified Plagiarism Checker to be accepted. DIFI may accept limited use of identical or nearly-identical phrases which describe a commonly- used methodology. The Plagiarism Check report should be attached to the Research Plan when submitting it to DIFI-Grants Portal.
- 12.3.6. **Budget:** for information on the budget, see the Budget Components document at DIFI-Website.
- 12.3.7. **Ethical Compliance:** For research involving human subject(s), LPI is required to comply with the laws and regulations set out by the Ministry of Public Health-Qatar (MoPH) for the protection of the human subjects. Foreign institutions must follow the appropriate regulations of the jurisdiction where the research will be conducted and must obtain prospective review and approval for research involving human subjects in accordance with the requirements of the jurisdiction where the research will be conducted. LPIs are required to submit MoPH assurances for studies done in Qatar or on Qatari sample. For more information, please visit MoPH website at: <https://research.moph.gov.qa/en/Pages/IRB.aspx>.
- 12.3.8. **Miscellaneous Documents:** This section may contain any supporting documents such as tables, appendices, etc. However, documents wrongly uploaded under this section, such as a research plan, will not be considered. All the information required for the evaluation process should be included in the research plan.
- 12.3.9. **Declarations:** The LPI should declare electronically that the proposal is his/her own work, except where appropriately referenced, and that the proposal did not and will not be submitted in whole, or in part, for funding twice within the same cycle or other funding agencies.

13. Proposal Screening

All submitted proposals are subject to screening by DIFI according to the screening process outlined at DIFI-Website before they can proceed to the Evaluation stage.

14. Proposal Evaluation

14.1. Proposal Review and Ranking


The proposal review and ranking process comprises a number of assessment steps, including peer review by international experts, followed by a programmatic review, which DIFI carries out. The two procedures are detailed below.

14.1.1. Peer Review (PR):
